ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the New Water Well Project will be received by the City of Moscow Mills at the office of the City Clerk at Moscow Mills City Hall, 995 Main Street, Moscow Mills, Missouri 63362, until **3:00 P.M. local time on February 28, 2023** at which time the Bids received will be publicly opened and read. The entire name of the project must appear on the outside of the bid envelope submitted to the City Clerk's office. The project bids will be opened and read aloud in the Council Chambers at Moscow Mills City Hall, 995 Main Street, Moscow Mills, MO 63362 at the date and time specified.

The Project consists of drilling and constructing a new drinking water well, piping and all necessary appurtenances.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis as indicated in the Bid Form.

The cost of printed Bidding Documents from the Issuing Office will depend on the number and size of the Drawings and Project Manual, applicable taxes, and shipping method selected by the prospective Bidder. Cost of Bidding Documents and shipping is non-refundable. Upon Issuing Office's receipt of payment, printed Bidding Documents will be sent via the prospective Bidder's delivery method of choice; the shipping charge will depend on the shipping method chosen. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of the Bidding Documents will not be available from the Issuing Office.

A pre-bid conference will be held at 10:00 A.M. local time on February 14, 2023 at the Moscow Mills City Hall, 995 Main Street, Moscow Mills, MO 63362. Attendance at the pre-bid conference is highly encouraged but is not mandatory.

Bid security shall be furnished in accordance with the Instructions to Bidders.

Bidders shall submit proof of qualifications to perform the Work as described in the Instructions to Bidders.
